Happy Holidays! Once again neighborhood lights on everyone's homes look amazing!

Updates to the Board this year include Tim Scates and Mike Stock continuing as Board President and Vice President. Don Dragisic sadly passed away this past year and Pat Dragisic retired from the board. Kelly Riojas joined as a member - yea! Melissa Scates continued as Treasurer and was appointed as Secretary. Four new homeowners were welcomed into the community with gift baskets.

We have a new pond management company called McCloud Aquatics. It is a local company that provided excellent service this year. Please do not blow grass clippings into the street. Materials in our streets wash into our storm drains and end up in our ponds. For example, nitrogen from grass clippings this year caused an increase in algae problems costing the HOA extra money to treat and directly contributed to being over budget this year.

Estimated Income of 144 homes x \$170......\$24,480 As you can see, costs are unfortunately rising significantly. The HOA is doing everything we can to keep from raising rates. Every homeowner's payment to the HOA is important and necessary!

As a reminder **ALL PAYMENTS ARE DUE BY JANUARY 31ST. LATE FEES ARE \$50.** Any payment not received by March 1st will be immediately sent to collections. There are currently 3 homeowners who have been sent to collections and 1 homeowner that the HOA filed a lawsuit and judgement was in favor of the HOA for nonpayment of dues in 2024.

Illinois law requires that an HOA keep a reserve fund. The HOA board took advantage of the great CD rates last year and placed all previous reserve funds in a 4.5% YTD CD that expires in 2028. The current balance in the reserve funds is \$20,884.

Summerfield HOA Rules and Regulations requires each property to notify the HOA of at least one working email. Emails are a way to decrease mailing costs and keep residents current with communication faster than mailings. We are currently missing sixteen homeowners email addresses. As a reminder, your email address will not be used for anything other than HOA use and will not be shared with anyone. If we are missing your email address, your annual dues letter will include a separate colored paper requesting this information. You can either mail it back to the HOA or fill out the 'Contact Us' form on the website <a href="https://www.summerfieldplfd.com">www.summerfieldplfd.com</a> with a current email address.

Do to a couple of recent complaints, here are a few trash, recycling and yard waste reminders:

Per City of Joliet ordinance Section 14-4, all cans should be placed behind the curb, not in the street, no sooner than 6:30pm the day before pickup and removed no later than 10 hours after collection. Please close those lids! We realize it's a pain to break down boxes, but your neighbors will appreciate the garbage staying in your containers and not their yards, especially with our crazy Midwest winds and animals. Per Summerfield Covenants enacted in 1993, Article VII section 8 states that no trash, garbage, or other waste containers shall be kept, or maintained anywhere except within the dwelling units or the garages of each of the lots, except on such days as such trash, garbage, or other waste material is to be collected and removed. This includes not storing cans in front of your home. If a fellow Summerfield resident decides to report you, you could be fined.

Mark your calendars for the annual HOA member meeting on Wednesday, June 4th at 6:30pm at Joliet Public Library off Black Road. The annual elections will occur during this meeting. Information will be sent by email starting in May for the election process. We are always looking for more volunteers for the board.
